

Documents needed when renting

Property owners need to know that prospective tenants have a good financial credit rating before they rent an apartment. To this end, Royal Velvet Real Estate has put into place several conditions that must be met before a tenant can rent a property. A basic condition that must be met is that the prospective tenant's gross monthly salary must be at least 3 times as much as the basic monthly rent. In all cases the owner of the property has the final say in choosing tenants. We reserve the right to perform a credit check on the potential tenant and will provide copies of all documents to the owner for approval.

Down payment

The only way to put an option on a property is to pay a down payment. The downpayment is half a month's rent (except for properties available for immediate occupation). Once you have rented the property, this down payment will be deducted from the total invoice.

Note: Candidates who are students or with a gross monthly income less than \in 800,- always need to have a statement of guarantee signed by someone who can prove that they have an income of at least 3 times the basic rental price of the property which they are intending to rent. This guarantor will also need to provide the above-mentioned documents to us.
